**Administrative Order** 

Pursuant to the provisions of articles (Thirty-Five) and (Sixty-Five) of the Iraqi Bar Code no. 173 for the

year 1965.

And the provisions of articles no. (23 & 24) of the Bar Board decision issued on its Tenth session in 31

March 2021, and later to our administrative order no. (1869) dated 1 March 2020 and based on the

authorities conferred to us, below is decided:

First: The minimum monthly fees for the lawyer appointed as the legal adviser for the local company and

industrial project equals to (300,000.00 IQD) Three Hundred Thousand Iraqi Dinar.

Second: The minimum monthly fees for the lawyer appointed as the legal adviser for the foreign company

and branches operating in Iraq equals to (600,000.00 IQD) Six Hundred Thousand Iraqi Dinar.

Third: The compensation of the Bar fund required to be paid by the local company and industrial project

for not appointing a legal adviser equals to an amount of (750,000.00 IQD) Seven Hundred and Fifty

Thousand Iraqi Dinars per month.

Fourth: The compensation of the Bar fund required to be paid by the foreign companies and their

branches in Iraq for not appointing a legal adviser equals to an amount of (1,500,000.00 IQD) One Million

and Five Hundred Thousand Iraqi Dinars per month.

Fifth: All companies (i.e. local companies and foreign companies and its branched in Iraq or industrial

projects) are obliged to pay the legal adviser fees in advance for each year starting the appointment date.

Sixth: All companies are obliged to pay all compensations incurred to it for the Bar fund for not appointing

Seventh: The Bar fulfill an amount equaling to (5%) of the lawyer's monthly fees for appointment as the

legal adviser to all companies provided that such companies shall undertake deducting the mentioned

percentage of the lawyer's fees and remitting the same with the Bar. The percentage should be settled to

the Bar fund in cash against a receipt issued for this purpose and indicated with the company's file and

financial records there.

Eighth: The Companies department is required to coordinate with the Administration Department at the

Bar to follow up all defaulting companies that did not settle the (5%) from the appointed legal adviser

monthly fees that are payable since the company incorporation and appointing a legal adviser.

Nineth:

1. The Bar shall withhold responding any submitted request by local companies, or industrial

projects or foreign companies or its branches in Iraq whether submitted directly form the

company or by the company agent attorney or legal adviser or from the Registrar of

Companies/Ministry of Trade or any other governmental authority unless that company pays all

obligations and compensations incurred for not appointing a legal adviser.

2. The requests referred to under clause (Ninth/1) above include requests for crossing off a company

from the Registrar of companies, winding up a company or merger with other companies or any

request for taking any action to a company regardless of the submitting party.

Tenth: The Companies Department at the Bar is obliged and legally liable for the strict enforcement of all

the above to secure withholding any response for any requests unless having the Bar financial rights

fulfilled by all companies.

**Eleventh:** 

a) This Board decision enters into force as of the first of May 2021, provided that the compensations

due to the company before that date shall be calculated as per the compensations applied earlier

with a discount of (90%) and calculated in full (100%) after the 1st of May 2021 without applying
