- 2. Allowing the process of exporting manufactured, semi manufactured, agricultural and raw goods and commodities under the name of companies registered with the Companies Registration Department/Ministry of Trade, and factories registered with the General Directorate for Industrial Development, and investment projects licensed by the investment commissions, and agricultural and livestock projects and all other projects duly licensed and individuals and offices registered with the Iraqi Chambers of Commerce.
